




# SOUTH DAKOTA UNIFIED JUDICIAL SYSTEM

### How to Use this Document

### Case Category

Cases are organized into one of five case categories. The table below lists the available case categories, their corresponding codes, and indicates whether they are available for initial filings, subsequent filings or both.

*Note: Initial Filings are not available for the Criminal Case Category.*

## Fees

If a filing code includes a fee, the fee amount is listed at the end of the filing code description. The fee will not be charged to your payment account until the filing is accepted by the clerk. If the correct filing code is not selected, your filing will be rejected.
